

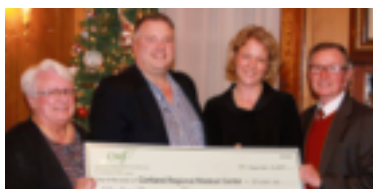

Dear Friends,

Community support has been the cornerstone of Guthrie Cortland Medical Center for over 127 years. Your gifts have built and furnished facilities, purchased leading-edge medical equipment and new technologies, funded patient-centered programs, and enhanced existing services. Your gifts have touched thousands of lives, and this donor report highlights just a few ways your generosity has made an impact.

Leading-edge Equipment for Early Diagnosis and Treatments

The Foundation launched a “40 Years of Giving” appeal with a goal of \$40,000 to purchase eight new infusion chairs, a bone marrow treatment table, and other small equipment for our new oncology infusion center. In the end, we raised \$55,000! The excess funds have been restricted to a Cancer Care Fund for the future needs of our oncology program that could include additional equipment, patient comfort items and educational materials, and advanced training for oncology staff.

Guthrie Cortland also received \$107,000 from the Foundation’s Capital Equipment Endowment for the purchase of a treadmill stress test system, automated endoscopes, and surgical instruments for orthopedic procedures.

Scholarships and Continuing Education

The Foundation’s four scholarship programs assisted 10 clinical staff members with academic and continuing education support. College tuition assistance was also awarded by the Foundation to three teenage volunteers.

Private Grants Making a Difference

The “Hope Now Breast Cancer Fund” is supported by grants from the Saint Agatha Foundation. This program provided financial assistance to 14 new individuals to help with the cost of breast cancer treatments and recovery-related expenses. The Hope Now program has assisted 137 individuals since it began in 2011.

Other grants received in 2018 included:

- Key Bank Foundation gave \$3,800 in support of the hospital’s Sexual Assault Forensic Exam (S.A.F.E.) program.
- Excellus BlueCross BlueShield awarded us a Community Health Award of \$4,000 for a “Smoking Cessation Program for Pregnant Women”.
- National Grid Foundation contributed \$2,500 for a “Food Prescription Program” – a preventive care program to address the needs of families at a high risk of diet-related diseases.

Employees Who Give Generously

The Healthcare Employees Reaching Out (HERO) Annual Giving Campaign held in October was a huge success with over \$51,000 pledged. Half of the funds raised were designated for the Foundation’s Employee Assistance Fund and the remainder will remain unrestricted to support future needs at the medical center.

These are just a few examples of your gifts at work. We extend a heartfelt thanks to you, our donor family, for your partnership in enhancing the quality of care for Guthrie Cortland Medical Center patients and their loved ones. Today at Guthrie Cortland, someone’s life was made better because of you.
