# Letter from the

At Guthrie, everything we do is centered on our vision to be the national model of excellence for rural health care. Our focus is to improve health through clinical excellence and compassion for every patient, every time. The strategic plan we embarked upon in 2022 is helping us bring that vision to fruition, keeping quality, safety, and patient experience as job number one in every move we make. Support from you, our incredible donors, allows us to improve our capabilities and patient access and to provide the highest quality care in the region.

The development of our Trauma Network is one example of translating our vision into action – a move that will help us respond to the most acute needs in our region. Research shows that time to trauma treatment is critically important to survival and better outcomes. Guthrie has risen to the occasion to fill a vital need by prioritizing the creation of a comprehensive Trauma Network for our 10,000-squaremile service area. Guthrie Troy Community Hospital has been a Level IV Trauma Center since 2016, and Guthrie Robert Packer Hospital has been a Level II Trauma Center since 1986, one of the first nine trauma centers designated in Pennsylvania. Our teams have worked to elevate Guthrie Robert Packer Hospital to a Level I Trauma Center, which means we provide the highest level of trauma care and meet requirements around research and education at that level.

Donor investments have been instrumental in supporting this mission to provide better access to timely high-level trauma care in our region. In addition to Guthrie Robert Packer Hospital's Level I achievement, Guthrie Corning Hospital has become a Provisional Level III Trauma Center, elevating treatment options in an area that was previously a trauma care desert. We also have our own air transport to move patients, as needed, between our facilities quickly and safely. Enhancing Guthrie's Trauma Network has allowed us to better coordinate complex and crucial care for our communities and beyond. No matter where our patients live, they will receive the best possible care at the right time and place.

Many of our communities have also been considered maternity care deserts. During a time when many health care organizations have been reducing maternity care services, Guthrie has doubled down and remains committed to ensuring our communities have access to high-quality, safe maternity care. That's what drives Guthrie's Maternity Care Oasis vision. The recent \$3 million gift from the Mother Cabrini Health Foundation is bringing that vision to life, enabling us to provide mobile prenatal care services throughout our region. These services will improve outcomes for our communities' mothers and babies, making highquality care more accessible.

With your support, we are bringing specialties like maternity, trauma care, advanced robotic surgical services, and primary care into our neighborhoods, making a difference by being local and by being "here for good." We believe people shouldn't have to go to New York City or Chicago or some other health care system to access the highest-quality care.

### Making Strides in Quality, Safety, and Patient and Caregiver Experience

When it comes to primary care, investments by our donors have enabled Guthrie to achieve the top 10% performance in national health metrics, known as HEDIS (Healthcare Effectiveness Data and Information Set). These metrics include a variety of health measures that are critically important to our community's well-being. For example, we now perform in the top 10% in the nation for diabetes control, which will translate to improved patient outcomes, life expectancy, and preservation of vision. Our donors have provided support for the caregivers and facilities we needed to rise to the top 10% for screening our population for breast cancer, resulting in the detection of 8% more cancers at the most treatable stage. This early detection helps some patients achieve remission without the need for intense therapies like chemotherapy and radiation. Your support has also helped more than 2,400 additional patients receive colorectal screenings, leading to more diagnoses of early-stage, more treatable colorectal cancers and significantly improving outcomes.

Guthrie has received many awards for orthopedics, maternity care, and management of chronic conditions like chronic obstructive pulmonary disease and heart failure – flexing our muscles to be among the best in the country.

Looking at patient safety, hospital-acquired infections are at record lows; in fact, our performance is also among the best in the nation. We have the highest Leapfrog Hospital Safety

Grades of any system covering a 10,000-square-mile region, and we're performing better than most areas across the United States. Leapfrog scores are meant to provide health care consumers with information about the quality and safety of hospitals to help them make informed decisions about where to receive their care. Grades are based on numerous national performance measures sourced from publicly reported data sources such as the Centers for Medicare and Medicaid Services (CMS). Guthrie is bringing nationally benchmarked, high-quality care and experiences to our region.

We continue to innovate the way we deliver care, committed to the idea that we will not be able to continue to provide care the same way tomorrow as we do today. This is due to the many headwinds affecting the health care industry, one of the most notable being workforce challenges. We aspire to serve our patients and communities better by leveraging technology that supports caregivers in providing exceptional patient care, not by replacing in-person care providers. The Pulse Center is a great example, representing a multimilliondollar investment to provide real-time access to care, virtual nursing so our nurses never work alone, and e-ICUs so that, wherever you are, you can receive the care you need at the right time and right place for you.

Last year, Modern Healthcare recognized Guthrie as one of the nine most innovative health care systems in the U.S. The Pulse Center has improved our nursing retention by reducing stress levels and enhancing the experiences of our caregivers and the quality of care we provide, making us a destination employer for nurses. The Pulse Center takes many of the required administrative tasks off the bedside caregiver's plate so they can focus on direct patient care and operate at the top of their training.

Both the Forbes Best-In-State Employer for Pennsylvania and the Forbes Best Employers for Women awards were spectacular first-time national recognitions for Guthrie and were based entirely on independent reviews of data from our surveys. We are so proud to provide every caregiver with a safe and inclusive work environment. Our provider retention rate is the highest we have ever seen. That means doctors and advanced practice providers are satisfied with their work environment and are sticking with us. Through these intentional efforts to become the best place to work and build a career, we've been able to markedly reduce temporary staff, building our permanent team of inspired caregivers.

### **Your Partnership Powers Our Mission**

Looking ahead, we continue to focus on what is best for our patients. The future of health care is bringing highquality care to the patient's home and having only the critically ill patients come to our facilities for vital care. We are looking at ways to safely monitor patients with chronic conditions such as congestive heart failure remotely, with an emphasis on preventing unnecessary emergency room visits. Moving care to the home requires us to make many investments in new technologies and our workforce to ensure we are always staying up to date with the best way to care for our communities.

Now that we have officially welcomed Guthrie Lourdes Hospital into the family, we are increasing services and enhancing access not only in our existing regions but also throughout Broome County. We will continue to innovate how we deliver essential preventive care, such as through that previously mentioned mobile maternity unit. Beginning in January 2024, we brought much-needed,

enhanced primary care to the greater Tunkhannock community in Pennsylvania with a medical office building featuring primary care, walk-in access, lab services, and imaging.

We are expanding OB/GYN services into Ithaca, sending certified midwives from Guthrie Cortland Medical Center to Guthrie Ithaca City Harbor, and enhancing our Cortland maternity labor and delivery programs as part of our overall mission to provide great prenatal and maternity care in areas that were previously maternity deserts.

While continuing to innovate, Guthrie will always remain committed to the mission and vision brought forth by Dr. Donald Guthrie more than 114 years ago: to provide the highest quality care to every patient, every time. Guthrie is bringing a new focus to health equity – offering the same level of outcomes to all populations we serve. To that end, we are doubling down on some of the most economically stressed parts of our communities to make sure they can access the same level of care. # Giving Back to the Community

Joe Reagan, President of Royal Chevrolet/Cortland Inc. and Royal Nissan-Subaru, and his family have supported the Cortland Memorial Foundation since his business opened in 1992. "I remember what a toll it took on my mother and how tough the travel was for her," he says.



Fast-forward to 2020, when Reagan himself had to receive radiation treatments. "I was able to receive treatments in Cortland, at the predecessor to the Renzi Center. This enabled me to take myself to treatments and continue to run my businesses and alleviated a whole lot of stress that would have otherwise affected my recovery," Reagan says. "I am overjoyed when I hear people are going to the Renzi Center because I know it will be a key part of their recovery. Bless the Renzi family for their exceptional generosity that made such a center possible."

In addition to Guthrie, Reagan and his family support several local organizations and their volunteers. "Volunteers are real heroes. To give up time to help and support others holds a special place in my heart. We usually support whatever my wife suggests, and I take all the credit," he jokes.

He encourages others in the community to support Guthrie in keeping exceptional care close to home. "If I had not lived near Guthrie in October of 2021 when I had a health crisis, I wouldn't be here today," Reagan says. "Being close to a regional health center saved my life. # **Inspiring Future Nurses in Memory** of a Beloved Wife

Marcia Hine Delaney was a lot of things a devoted wife, mother, sister, and grandmother; an active member of her church, Sunday School teacher, and exceptional choir singer; and a woman with a beautiful smile, great sense of humor, and countless friends. Even after she stopped practicing, she always identified as a nurse. Her husband, Richard Delaney, MD, felt she would be honored by a scholarship in her name, supporting others pursuing nursing.

Marcia grew up on her family's dairy farm in Newfield, New York, and earned her nursing degree from Corning Community College. She worked at several hospitals throughout her career and always spoke highly about her time as a nurse in the thoracic step-down unit at Guthrie Robert Packer Hospital.

Working at a different hospital, in Columbia, Missouri, she met Dr. Delaney when he was doing his residency, and they married in 1979. Their two children were born in Maryland before they moved as a family to the Daytona Beach, Florida, area in 1984, where Dr. Delaney is an anesthesiologist.

"Though she stopped working as a nurse after she had our first child, she never really left the profession," Dr. Delaney says. "She was always giving people medical advice on the phone. People from our church would call her with questions and she gave them the answers they needed or helped connect them with someone who could."

Even though she spent much of her life in other states, Marcia was always at home farther north - in Guthrie territory. Her siblings still live in upstate New York, and every August, she would head up to the area for two weeks on her own before Dr. Delaney joined her for an extended vacation.

Back in Florida, she raised her children and maintained very close relationships with them; worked as a church secretary; taught Sunday School, where she mentored young women, encouraging them to be independent and to pursue their education and dream careers; sang alto in the church choir; and regularly brightened everyone's day.

Marcia first fell ill in April 2020 and was diagnosed with a high-grade glioma. She bravely underwent several surgeries and rounds of radiation, bouncing back several times, but sadly passed away in April 2023. Dr. Delaney is grateful to all the nurses who helped him care for her in her final months.

"Marcia was a cheerful person who lit up the room and was a bit of a comic. People just wanted to be around her," Dr. Delaney says. "She loved her time with Guthrie, and they need nurses so much, so I wanted to establish the scholarship in her memory to encourage someone from the Southern Tier to pursue their dream of nursing. Nursing truly is a calling and is so much work, but there's great reward as well. Marcia always liked taking care of her patients and interacting with them, and I know she'd love for others to have that opportunity at Guthrie."

# Setting the Standard for Rural Trauma Care

In July 2023, Guthrie Robert Packer Hospital received accreditation by the Pennsylvania Trauma Systems Foundation Board of Directors as a Level I Trauma Center, the only one in The Guthrie Clinic's 12-county service area.

Though its Level I designation is fairly new, Guthrie Robert Packer Hospital already had the required specialized orthopedic, plastics, and neurosurgical care in place, years before its journey from Level II to Level I. The hospital has also offered a general surgery residency for more than 65 years.

The differentiator was trauma research, according to Lisa LaRock, RN, Trauma Center Manager at The Guthrie Clinic/Guthrie Robert Packer Hospital.

Getting to Level I was an entire-facility effort. The initiative was led by LaRock; Anne Rizzo, MD, System Surgical Chair and President of Surgical Services; Steven Casos, MD, FACS, Trauma Center Medical Director; Robert Behm, MD, FACS, a trauma surgeon who LaRock calls "the key person who allowed us to accomplish our research publication goals"; and Burt Cagir, MD, FACS, Executive Director of the Donald Guthrie Foundation, who helped the team create a sustainable pipeline of research for years to come.

"Our research program is key to our educational mission at The Guthrie Clinic," LaRock says. "We collaborate with all trauma-related residencies and fellowships to optimize care with a rural area focus. Creating a rural trauma system with Guthrie Troy Community Hospital and Guthrie Corning Hospital has positioned us to experience, research, and publish best practices in clinical care in a rural trauma system.

These publications can help improve care at rural centers throughout the nation."

Research efforts at Guthrie have yielded more than 20 trauma-related publications in peer-reviewed journals, reflecting exciting research into treatments like 1:1:1 blood component resuscitation for traumatic injuries.

"This has been studied as a best practice to optimize patient survival by the military during recent conflict injuries," LaRock says. "For the last three years, we have offered our patients 1:1:1 blood component resuscitation and we have begun offering whole blood as well, which is shown to have the greatest impact because it possesses all of the blood components and is essentially 1:1:1 therapy in one bag."

Publishing innovative and effective research on trauma care in a rural setting also helps Guthrie's efforts to attract talented caregivers, as well as medical students eager to learn from our educators. Six of the center's eight acute care/trauma surgeons were trained at Guthrie Robert Packer Hospital, completed acute care surgery fellowships across the nation, and returned to Guthrie for their careers. In the future, Guthrie hopes to offer General Surgery residents the ability to complete a Trauma Surgical Critical Fellowship right in the health system.

Guthrie Robert Packer Hospital has seen an increase in severely injured patients since its accreditation, including an increase in those requiring emergent operative care and intensive care unit admission. Trauma centers must meet specific standards to maintain accreditation, and Guthrie Robert Packer Hospital constantly monitors care and makes improvements quickly and effectively to ensure each patient is receiving the most appropriate and effective treatment.



### A Trauma Network with a Shared Mission

In August 2023, Guthrie Corning Hospital was designated a Provisional Level III Trauma Center by the New York State Department of Health. Provisional status is granted to new trauma programs in New York until they are verified by the American College of Surgeons. The Level III designation requires hospitals to have a 24-hour trauma team in place, and emergency medical supplies and specialized equipment designed specifically for treating traumatic injuries.

"Becoming a Level III Trauma Center reaffirms Guthrie's commitment to our community's well-being," says Anne Rizzo, MD, Trauma Medical Director. "This designation puts Guthrie at the forefront of health care systems in rural settings and solidifies our dedication to providing reliable and accessible emergency services for our patients."

Guthrie Troy Community Hospital is a Level IV Trauma Center accredited by the Pennsylvania Trauma Systems Foundation.

Dr. Fedele followed their advice, completing his undergraduate studies at Villanova University, attending medical school at the University of Bologna, and later completing a dermatology residency at Case Western Reserve University Hospitals Cleveland Medical Center.

Dr. Fedele was a U.S. Army dermatologist living in Germany when the opportunity arose to practice at Guthrie. He and his wife, Kathleen, moved to Sayre in 1977, where they've lived ever since.

"I practiced at Guthrie from 1977 until I retired in 2007. I was only the second dermatologist Guthrie ever had, after Dr. James Flood, and one of the reasons I was attracted to the job was that it was a multispecialty clinic with a wealth of medical and surgical specialties that drew patients from many miles away," says Dr. Fedele. "When Dr. Flood retired, I helped recruit dermatologists until we were five in number."

There, Dr. Fedele and his colleagues treated both inpatients and outpatients and offered what was then state-of-theart treatments like PUVA (psoralen plus ultraviolet A photochemotherapy) and methotrexate for severe psoriasis.

During this time, Dr. and Mrs. Fedele embraced life in the Sayre community, raising their three children, forming lifelong friendships, and enjoying their proximity to the scenic Finger Lakes region. Dr. Fedele appreciated the unique blend of small-town living with access to a university hospital, while Mrs. Fedele noted the deep sense of pride the community had in its local health system.

"When we first heard of Guthrie, we didn't realize just how big it was or about all of its medical research and the caliber of its physicians, but we quickly learned," says Mrs. Fedele. "Education has always been very important to us, and it's amazing the level of education going on at Guthrie every day. We recently went through the Guthrie Robert Packer Hospital Simulation & Advanced Skills Institute, and the level of skill and dedication shown by the physicians, residents, interns, nurses, and medical students who go into this high-tech environment to practice and perfect their treatments and procedures is remarkable."

The Fedeles say that while a lot of people move after retirement, they've never been compelled to leave Sayre – or Guthrie.

"We feel it is a privilege to give back to the place that's given us such a good life and treats so many patients," Mrs. Fedele says. "It's our obligation to look out for the welfare of others and, in a rural area like ours, there is a very big need. Not everyone can travel 100 or 200 miles to get high-quality health care."

Dr. Fedele, who continues to serve as a member of the Guthrie Community Benefits Committee, says a thriving medical center is vital to the well-being of the community. He is particularly proud of the expansion of outreach clinics over the years and the exceptional progress in the training programs offered in Sayre.

"You don't know how healthy you are until you're not," Dr. Fedele says. "And when you're not healthy, you really want a Guthrie Clinic in your area – that's why it's important to invest in its future."

# A Cife to Help Guthrie Bridge Gaps in Maternity Care

Doing all we can to promote the health and safety of mothers and babies creates a strong foundation for healthy families and communities.

Guthrie's goal to become a national leader in rural health care and better serve the needs of our patient population includes a focus on empowering mothers, promoting healthy births, and reducing maternal health disparities.

"We are dedicated to nurturing the well-being of expectant mothers, ensuring their journey into motherhood is safe, healthy, and supported," says J. Manuel Arreguin, MD, MS, MBA, FACOG, Chair of Obstetrics and Gynecology at Guthrie.

A \$3 million gift from the Mother Cabrini Health Foundation that we received in February 2024 has been a significant boost for these efforts – known collectively as the Maternity Care Oasis initiative. Guthrie's Maternity Care Oasis initiative seeks to bridge gaps in maternity care by providing compassionate, accessible, and expert maternity services within underserved communities. The enormously generous gift from the Mother Cabrini Health Foundation helps Guthrie secure and support a key feature of our new program: a mobile maternity unit.

"Over the past five years, we have worked to get funding into communities across the state struggling with heightened health inequities. The mobile maternity unit will connect pregnant patients and new mothers with comprehensive prenatal care, childbirth support, postpartum guidance, and education. Caregiver teams of midwives, doulas, and other community workers will also be dispatched across Guthrie's New York service area to provide outreach, education, and essential maternity care.

"Rural communities face significant challenges in accessing comprehensive maternity care services, leading to disparities in maternal and infant health outcomes," says Edmund Sabanegh, MD, MBA, President and CEO of The Guthrie Clinic. "We are determined to play a role in addressing these issues, and through their generosity, the Cabrini Health Foundation is partnering with us to make an enduring difference for those who depend on us for this care."
